- ◆ CF Merchants Limited may accept all and any instructions given by the Appointee as if they were given by me and shall not be responsible for any acts or omissions on their part.
- ◆ I understand and accept that the conduct of my account remains my full responsibility and my obligations under my Client Agreement with CF Merchants Limited are not diminished in any way by my signing of this Power of Attorney such that, any instructions given by the Appointee may fully be deemed to have been given by me directly or any abuse of the services provided by CF Merchants Limited, by my Appointee, will remain my responsibility.
- ◆ I understand that the appointment made under this Power of Attorney and its contents shall be part of my Client Agreement with CF Merchants Limited and that the Client Agreement permits CF Merchants Limited to reject any instruction or request given by my Appointee if, in their sole discretion, they have reasonable cause(s) to believe such rejection to be appropriate.
- ◆ I fully indemnify CF Merchants Limited against any act or omission on the part of my Appointee.
- ◆ I undertake to provide written notice to CF Merchants Limited of any intention to terminate any appointment made under this or any other Power of Attorney.
- ◆ Attorney and that such notice may not deem to have been received and acted upon by CF Merchants Limited unless and until I have received written confirmation from them.
- ◆ This Power of Attorney shall be subject to the same legal jurisdictions of English law and the this Deed (Power of Attorney) shall be governed by UK Law and the parties here to submit to the non-exclusive jurisdiction of the UK Courts as regards to any claim or matter arising in relation to this Deed.
